Report Description: AV is [REDACTED], PRFC is [REDACTED], and AO is [REDACTED]. During the interviews, PRFC, [REDACTED] reported to FSWS Emery that approximately 3 weeks ago, she took [REDACTED] to the dentist. He was bragging to his brothers that he has a 35-year-old girlfriend named [REDACTED] at the facility (Dacus Psychiatric Residential). [REDACTED] stated that they were having sex in the bathrooms because there were no cameras there. [REDACTED] reported it to the facility staff, who failed to report it to the director or to the [REDACTED]

Interim Action Narrative: The staff was terminated from the facility on 12/18/2023 due to another incident that occurred on 12/17/2023 with the same A/V.

Maltreatment Narrative: AV is [REDACTED], PRFC is [REDACTED], and AO is [REDACTED]. During the interviews, PRFC, [REDACTED] reported to FSWS Emery that approximately 3 weeks ago, she took [REDACTED] to the dentist. Licensing Narrative: 12/21/2023-Program Manager was made aware of this investigation by the DON during a visit to the facility. The Program Manager was given details about the investigation and the name of the person investigating it. The investigator was on site at the facility and informed them of the report yesterday 12/20/2023. Camera footage was reviewed for interactions between the A/V and A/O during the day of 12/17/2023. Permission will be requested from the investigator before licensing proceeds with any further investigation. The Program Manager spoke to the investigator after the visit and discussed what was viewed on the camera footage seen today. Permission was granted for licensing to continue with further investigation. 12/28/2023, Program Coordinator followed-up with the investigator on whom the guardian spoke with. 1/5/2024, Program Coordinator contacted the investigator for updates. 1/19/2024, Program Coordinator reached out to the investigator for an update. 1/24/2024, Program Coordinator informed case is still pending. 2/9/2024, case is still pending according to CHRIS. 2/22/2024, Program Coordinator checked CHRIS for an update and reached out to the investigator. Investigator Burns informed Program Coordinator case is still pending. 3/8/2024, Program Coordinator reached out to investigator for an update. Investigator reported that case is still pending and is awaiting on camera footage from Methodist.
