On November 5, 2023, at approximately 4:40 PM, unit 1386 was parked at Piney Ridge located at 4253 N. Crossover Road after transporting three juvenile runaways back to the facility (Incident 2023-74373). While speaking with staff and creating a plan for the three juveniles to be removed from my patrol unit and into the facility without running away, two of them, **and the set of the** 

As staff and officers were getting the subjects out of the vehicle, staff noticed the bulge in their pants and searched them discovering the magazines. All magazines were returned and no other items were located missing or on the subjects. When speaking of how they gained access, one stated "we bent it down." I advised them of felony criminal mischief charges with the juveniles stating, "like we give a fuck." Damage to the cage was valued at approximately \$1350.00 for replacement of the partition. The juveniles were escorted into the facility by staff as citations were printed for the charges. Staff member Anna Moore signed the citations since both juveniles are in DHS custody at this time. Photos of the damages were uploaded to Axon using Axon Capture on my issued phone.
