Bathrooms clean and sanitary with functioning sinks, showers and toilets. Building clean, safe and in good repair except rooms 3 had torn baseboard and room 5 had baseboards completely missing. Maintenance ticket was observed for baseboards in room 3. Maintenance worker was consulted today whom stated he was gluing baseboards in room 3 and replacing and gluing baseboards in room 5. The baseboards are in the process of being removed and replaced to spackle, repaint walls. Kenleigh Bennett of Timber Ridge explained that the single rooms walls are in the process of having puncture resistant white lining installed for walls. One single room observed to have this today. T/A given for 911.6: All buildings shall be clean, safe and in good repair.
