On December 12, 2023, I Officer Keys was dispatched to Perimeter Behavioral Health in reference to a Runaway Juvenile. Upon my arrival I spoke with Cliff Williams, who is the Director of this Health Unit. Williams stated [REDACTED] escaped from the building through a hole he made under the safety fence. Williams states he gave chase but could not convince [REDACTED] to stop and come back. [REDACTED] is a 17-year-old white male, last seen wearing a red and black jacket with some black sweats. Williams states the jacket is a really bright red and you will not miss him. While I was at the main building gathering more information on [REDACTED], Sgt.Mansel found him on Spring way Street. [REDACTED] was brought back to The Health Unit, and EMS was called for his injuries. [REDACTED] has scratches and scrapes to his arms and wrists where he went over the fence. [REDACTED] was transported to Forrest City Medical Center for Treatment.
