Narrative & Statements

Arrest Notes - 23-A02582

Assisting Officers: Kimbro #252, Strayhorn #259, Pegues #281

On December 24, 2023 at approximately 3:28 PM, I, Officer Ester #292 was dispatched to 600 N 7th Street (Perimeter Behavioral Health) in reference to a juvenile complainant.

Officers arrived on scene and made contact with Perimeter Behavior Health staff stating that the arrestee / [REDACTED] was being disruptive and did not want to comply with the policies and procedures of the facility. Officers were advised by staff that [REDACTED] was no longer welcome to receive treatment and needed to be transported back to the Crittenden County Juvenile Detention Center.

Officers made contact with [REDACTED] and advised [REDACTED] that [REDACTED] was being placed under arrest and being transported. [REDACTED] became irate as officers escorted [REDACTED] to the police cruiser. As [REDACTED] was placed into the cruiser, [REDACTED] began to hit [REDACTED] head against the plexiglass divider. [REDACTED] began to bleed from [REDACTED] forehead due to the constant banging against the divider. EMS was called to the scene to treat [REDACTED] forehead. [REDACTED] repeatedly told officers and medical personnel that [REDACTED] did not want any medical treatment. [REDACTED] declined treatment or to be transported to the hospital by EMS but did allow medical personnel to irrigate the lacerations on [REDACTED] forehead and bandage [REDACTED].

[REDACTED] was transported to Crittenden County Juvenile Detention Center where [REDACTED] will be placed on a CIT hold for mental evaluation due to [REDACTED] making statements that [REDACTED] wanted to die and wanting officers to shoot [REDACTED].

Per intake officer Lancaster, Perimeter Behavioral Health will conduct a mental evaluation on [REDACTED].
