On January 9, 2024, at approximately 3:11 p.m., I, Officer Kimbrough 271, responded to Perimeter Behavioral Health, 600 N 7th St., in reference to a fight.

I made contact with the complainant, Jeremy Woods. Woods advised that they heard a commotion and saw that two of the residents were in a fight over stolen property. Woods helped separate the two and grabbed the property. At this time the arrestee, [REDACTED], attempted to grab it back. When [REDACTED] was not able to get the property back [REDACTED] became irate and pushed Woods, grabbing him. Woods and witness, Bobby Crawford, attempted to put [REDACTED] into a hold, and [REDACTED] punched Woods in the face. At this time they began fighting while Crawford and witness, Walter Sanders, attempted to separate the two of them.

[REDACTED] was taken to a holding room until police arrived. I reviewed the video footage and was able to confirm the statements of Woods, Crawford, and Sanders. Woods did have a busted lip, but had already cleaned it before I made contact with him.

[REDACTED] was transported to CCJC. Intake Officer Williams advised that [REDACTED] will be held until tomorrow at 9:00 a.m. for intake.
