Resident had become escalated on several occasions leading to her punching the wall multiple times. While at the emergency room resident was diagnosed with a [REDACTED] no fractures or breakage. The resident returned to the facility around 1800 with no new orders. Our medical doctor was notified, and the hand is continuing to be monitored. As of today there is no other reports of her hitting walls and the swelling has decreased. Corrective Action: Resident taken to Emergency Room Medications ordered and being given as such. Will be monitored by nursing staff to make sure condition improves. Resident placed on self-harm precautions. Continued working with therapist to use coping skills.
