Report Description: On 2/1/24, [REDACTED], eloped out of the building at 8:24am. [REDACTED] (staff) stepped inside of the office, [REDACTED] picks up a chair the staff was seating in and begin walking down the hallway with the chair. [REDACTED] walks inside of [REDACTED] (client) room with the chair who was in the bed due to refusing to get up. While [REDACTED] is standing in the doorway talking to [REDACTED], the fire alarm starts going off. [REDACTED] waits a second, the fire alarm continues to go off, [REDACTED] then put the chair down and walk to the exit door and go out of the door. She goes down the stairs to the first floor and go out of the building. [REDACTED] gets up and go report to the staff that [REDACTED] has went out of the door. [REDACTED] (nurse) runs down the hall to look for [REDACTED] and other staff comes to assist. [REDACTED] did not leave off campus, she returns to the front door at 8:27 am and rings the doorbell. The therapist opens the door and walks her back to the unit.

Program Coordinator reviewed camera footage for the provider reported incident with Methodist staff.

Resident was observed in the foyer standing by a wall. Where the resident was standing, Program Coordinator observed ratio 1:2. There was a resident sitting on the floor by the wall. Program Coordinator observed another staff member enter the foyer area.

Resident was observed walking down the hallway with a chair to a peer's bedroom. Resident entered the peer's bedroom with the chair. Program Coordinator observed the lights flashing on the hallway. Staff reported that a quarterly drill was being conducted at the time of this incident. Because of the drill/alarm, the magnetic doors automatically unlocked.

Program Coordinator observed resident run toward and out of the exit door. The peer was observed walking down the hall to alert staff that resident went out the exit door. Staff was observed running down the hall and through the door that resident left out of.

Facility reported they will work with maintenance to prevent future incidents of this nature when drills are being conducted.
