Resident was observed in the classroom before entering the educational hallway. Program Coordinator observed resident in a fetal position on the floor with his hands over his head before kicking and hitting walls. Resident's sweater was observed on the floor before being picked up by resident.

Program Coordinator observed resident pick his sweater off the floor and place the sweater on his shoulders. Before wrapping the sweater around his neck, resident was observed moving his hair from under the sweater. Staff was observed walking up to resident to remove the sweater. Program Coordinator observed staff struggling with resident to get the sweater. Staff was able to remove sweater from around the resident's neck and hands.

Resident returned to the floor in a fetal position and what appeared to throw a tantrum.
