*****Officer Cristian Hernandez #343 Narrative*****

On February 27th, 2024, at around 1902 hours, I was advised by dispatch to call a Mariangela Good (W/F D.O.B. [REDACTED]) for an assault. I called Good and she advised that she responded to two juvenile females fighting at 2466 South 48th Street (Perimeter of the Ozarks). Good arrived on scene and attempted to separate the fight. When Good intervened and was trying to hold [REDACTED] (W/F D.O.B. [REDACTED]) back, Good stated that [REDACTED] intentionally punched her in the face and left her lip swollen. I asked Good what it was that she work as and she stated that she worked for Perimeter of the Ozarks which was a facility for female minors who were suffering from PTSD.

Good stated that she had video surveillance and I advised her that if she could, to reach out and request a copy of it. Good was advised to write a written statement for what had occurred and to turn it in as soon as possible. Good also stated that other officers responded to the incident and took another worker's statement for battery as well.
