Narrative:

On Monday, 02/26/2024 at approximately 1440 hours I responded to 2466 S 48th St B (Perimeter of the Ozarks Behavioral) for an Assault/Battery report. I made contact with Blair Parson (W/F DOB: [REDACTED]) who was an employee. She advised she was attacked by one of the Juveniles that was a patient of the Behavioral health unit. The juvenile was identified as [REDACTED] (B/F DOB: [REDACTED]). [REDACTED] is a ward of the state and assigned a DHS caseworker.

Blair advised she was tending to another juvenile and making sure she was in her room when [REDACTED] punched her in the face two times, grabbed her by her hair, and pulled her to the ground. Other employees had to separate the two and had to restrain [REDACTED]. Blair had a scratch mark on the left side of her cheek from [REDACTED]. I took photographs of the injury and later uploaded them to the server. Blair advised she wanted to press charges for the Battery. I provided her with the report number and advised I would be filing the report for Battery.

On Thursday March 21, 2024 I went to Blair's listed address and spoke with a resident that confirmed that she lived at the address. I provided the resident with my buisness card and informed him that I would not be able to continue the investigation until I was able to reach Blair. The resident agreed to pass the information to Blair when she returned home.

I am closing the case and moving to inactive status pending victim contact.
