

They continue to laugh and joke during the duration of the evening until the client goes to bed. The staff had pour boundaries of horse playing with the clients. We have instructed her that this can not happen moving forward. We have not been able to find any evidence that the client reported this to the nurse of the "busted lip." On the next incident, you see client get upset after phone call with her mom. She came out of the phone booth, yelling, cursing, at staff. Staff redirect client about behavior, and client throws shoe at staff
the shoe and takes it into the Bi office. We have not been able to find any evidence of staff throwing a shoe at client

Licensing received a complaint on 3/4/2024 for ELS Case #019579.

Program Coordinator reviewed camera footage with United Methodist Children's Home Little Rock Campus staff. Program Coordinator reviewed camera footage for both incidents and requested nursing note.

First video, residents and staff were observed in the foyer area. Program Coordinator observed resident and a staff member horseplaying. Resident was observed throwing a material object at a staff member and running into the bathroom. Program Coordinator observed staff member going toward the bathroom behind the resident.

Staff member was observed entering the bathroom with resident. Another staff member and peer were observed going toward the bathroom. The peer stood outside the door and the staff member stood in the doorway of the bathroom. While in the bathroom, Program Coordinator heard resident making sounds, but no sounds of distress.

The staff members and peer left the bathroom area. Briefly after, resident was observed coming out of the bathroom and continued to horseplay with staff. Resident did not appear to be in any pain, nor did she complain of being injured. Program Coordinator heard resident mention that she had fallen but a fall was not observed during the camera review.

Second video, resident was observed coming from the area where she was on the telephone. Entering the foyer, resident appeared to be upset. Program Coordinator heard resident cursing at staff. Staff could be heard trying to de-escalate the resident.

Program Coordinator observed resident throw a shoe at a staff member. The staff member was observed picking up the shoe and walking toward the BI Office. The staff member was not observed throwing the shoe at the resident. When the resident attempted to follow the staff member, another staff member blocked resident from following the staff member.

Licensing is not prepared to leave a finding at this time.
