At approximately 4:00 pm on Saturday March 2, 2024 I, Officer Morris, was dispatched to 211 Church St,

Dacus, for a Juvenile attacking the facility staff. When I arrived, deputies with the Craighead County Sheriff's Office was already on scene.

I made contact with Kyle Williams and Charlotte Smith. They deputies was in contact with the juvenile. Kyle advised that he had been punched in the face by the juvenile multiple times. He advised that he was assisting Charlotte with the juvenile because the juvenile was throwing shoes and threatening to kill, stab and choke Charlotte. He advised that it took two of the facility staff to gain control of the juvenile.

Charlotte advised that the juvenile was trying to keep her out of the nurse's office and that the juvenile threatened to choke, stab, and kill her. She also advised that he threw his shoes at her.

I made contact with Shannon Lagrone with the Craighead County Juvenile Office. Shannon advised that I should make a report and have the facility contact the Juvenile Office on Monday morning. Shannon advised that the facility should keep the juvenile separated from the other juveniles at the facility. I advised Kyle and Charlotte on what Shannon told me.

Kyle and Charlotte both wrote statements about the incident.
