NARRATIVE

ON MARCH 7TH, 2024 AT 1501 HOURS, I MADE CONTACT WITH CYNTHIA RAGLAND AT THE 12TH STREET PATROL SUBSTATION. RAGLAND WAS REPORTING AN ASSAULT.

RAGLAND ADVISED TODAY, AROUND 0930 HOURS, SHE WAS ATTACKED BY A JUVENILE AT THE METHODIST CHILDREN'S HOME. RAGLAND IS A BEHAVIORAL INSTRUCTOR AT THIS BUSINESS.

RAGLAND SAID THE JUVENILE PULLED HER HAIR, PUNCHED HER IN THE RIGHT SHOULDER AND GRABBED HER WRIST THEN TWISTED IT IN WAY THAT RAGLAND BELIEVED IT TO BE INJURED.

RAGLAND WENT TO BAPTIST HEALTH URGENT CARE AND RECEIVED AN X-RAY ON HER WRIST. MEDICAL DOCUMENTATION PROVIDED BY RAGLAND SHOWED THAT THERE WAS NO DEFINITE EVIDENCE OF A FRACTURE OR ACUTE BONE ABNORMALITY. THE DOCUMENT PROVIDED BY RAGLAND WAS ATTACHED TO THIS REPORT.

WHEN I SPOKE WITH RAGLAND, SHE DID HAVE INJURIES CONSISTENT WITH HER STATEMENT, BRUISING TO HER RIGHT SHOULDER AND BRUISING TO HER LEFT WRIST. RAGLAND SAID THE METHODIST CHILDREN'S HOME HAD THE INCIDENT ON CAMERA. RAGLAND WAS ADVISED TO OBTAIN THE VIDEO FOOTAGE AND TAKE IT WITH HER AND A COPY OF THIS REPORT TO THE PROSECUTOR'S OFFICE TO FILE FOR A WARRANT.
