Program Coordinator Rice completed buildings and grounds for Little Creek. Nedra, Director of Nursing, and Reggie, Residential Coordinator, escorted Program Coordinator throughout the building and grounds.

The following areas were observed: grounds, lobby, classroom hall, residential wings, gym, playground, bathrooms, laundry area, dining room/cafeteria, nursing station, linen closet, and cafe.

Residents were transitioning to their classrooms while walking through the educational hall. Residents were informed to move to the opposite of the hall while Program Coordinator and staff walked down the hall.

Program Coordinator observed paper sacks outside of each unit that are used for residents to put trash. Each unit (Minnows, Guppies, Starfish, and Angel Fish) was observed. There were either one or two residents to a bedroom. Bedrooms observed furnishings were in good condition and cach bed was equipped with bedding.

The bathrooms are shared among the residents on each unit. Towels, tissue, and games are kept in the linen closet on the units. Program Coordinator observed locked cabinets in the laundry area where residents' hygiene products are kept.
