Runaway Juveniles

On 3/14/2024, at approximately 1916 hours I, Deputy Knobloch and Sgt. Cox, were dispatched to the Youth Home located at 20400 Colonel Glenn Rd, Little Rock, AR 72210 in regards to two runaway juveniles.

Upon arrival, I canvassed the area while Sqt. Cox spoke with Youth Home employees. I was unable to locate any juveniles while doing so. I then met with Sqt. Cox and Youth home employee, Schree Eackles. Ms. Eackles advised that at approximately 1912 hours she was allowing the boys that resided in the Sturgis House to play basketball outside. Ms. Eackles stated that juvenile and juvenile took off running toward Colonel Glenn Rd. Ms. Eackles then notified her supervisor who notified 911. Youth Home employees then canvassed the area as well but were unable to locate the boys. was last seen wearing a black jacket and black jeans. seen wearing a cream-colored hoodie, jeans, and white Nike Air Force Ones. No workers on the scene were able to provide any information on where the boys might have gone. Upon speaking , I was advised that had run away previously and is known to hitchhike. with father, believes that will attempt to contact his brother so he can get a ride back to his home state of Oklahoma. I then spoke with mother, was unable to provide me with information on where the boys may have gone.

Sgt. Swygart advised me that he observed two males matching this description attempting to hitchhike on Crystal Valley Rd. When Sgt. Swygart attempted to turn around and speak with them, the pair ran into the woods. Deputies were unable to locate the pair after a thorough search.


Both juveniles have been entered into ACIC/NCIC as runaways. Deputies will continue to search for the pair.
