Upon arrival, I made contact with staff who lead us into the facility and back behind the westside of the building. There was a female juvenile being restrained on the ground by four staff members. I later identified the female juvenile as (DOB: ). The victim, later identified as was trying to escape the facility by climbing the fence that was (DOB: ), stated surrounding the perimeter. by grabbing her shoulder to prevent her from climbing the fence any further. jumped off the fence and punched her in the left eye and broke her glasses. pulled on the 's hair till other staff members were able to assist in restraining her. , checked for tightness and double-locked the cuffs. I moved I handcuffed and detained an isolation holding room. I removed the handcuffs while was in the room so she could change out of her ripped clothing. I handcuffed again after she changed into new clothes provided by staff. I checked for tightness and double-locked the cuffs. left eye. I photographed multiple pictures of I observed slight swelling and her broken glasses through Axon Capture application. notified me that the glasses were valued at \$195. I contacted Washington County Juvenile Intake and provided information regarding guardian is the state of Idaho with a case worker, Trisa Dunbar, assigned to her. I attempted to contact her case worker several times by phone without success. Washington County Juvenile Detention Center gave the juvenile an arraignment date of 03/29/2024 at 8:15AM. Officer Barron #399 transported Washington County Juvenile Detention Center. I completed an e-cite for giving

Before speaking to staff members about the incident, (H/F DOB: was put in a holding cell type room. While in the room she repeatedly kicked the door and tried to force it back open. As the door was not able to be locked fully and her combative and aggressive behavior. I had to go back to my patrol car to get leg restraints. After getting them on her she calmed down. Perimeter staff said that was trying to escape the facility by jumping over the fence. While she was attempted to jump over the fence a staff member was trying to stop her. The staff member grabbed by the shoulder to stop her. After turned around and punched a staff member in the face, breaking her being grabbed by the shoulder. glasses and causing her pain.
