I spoke with Allyson Shivers (complainant) by cell phone. Ms. Shivers is the director of admissions for Little Creek Behavioral Health (victim business). Ms. Shivers stated an unknown male (offender) left a bizarre voicemail on their office phone. Ms. Shivers stated the voicemail was left sometime after business hours and she had a recording of it. I listened to the recording of the voicemail and could hear a male subject state "One day there is going to be a suicide or murder because you fucks can't answer the goddamn phone". Ms. Shivers stated she was unaware of who the male was but the number he called from was

Ms. Shivers provided me with the voicemail recording to be uploaded to the "patrol pics" folder. I advised Ms. Shivers I would be doing a report to document the incident. Ms. Shivers was given this report number and advised how to obtain a copy.
