**Notice of Serious Incident**

Report Description: On 4/3/24 at approximately 1410, resident [REDACTED] was sitting in the classroom and beside him resident [REDACTED] was sitting. [REDACTED] reported that [REDACTED] started to talk sexual, showed [REDACTED] his penis, briefly placed his hand on [REDACTED] clothed crotch area and then [REDACTED] talked sexual and "made" me touch his penis (which was outside his pants) briefly. Staff turned around and saw [REDACTED] buttoning up his pants. Residents were separated, [REDACTED] [REDACTED] [REDACTED] will be at the facility this afternoon. [REDACTED] has a disruption in place, a meeting is occurring at 1300 with his team to discuss removal, referrals will be sent out to Acute facilities and [REDACTED] will not be sleeping in patient bedrooms. He is on additional observation that will be assessed every 24 hours. Re-education will occur with staff.

Interim Action Narrative: Residents were placed on safety precautions to prevent further contact with one another. The alleged offender will be separated from other youth as to not have a roommate.

Licensing Narrative: 4/16/2024 - The provider reported incident was reviewed by Licensing Specialist Jarred Parnell. Licensing Specialist conducted a visit at the facility to review video footage of the provider reported incident. Video footage was reviewed for 4/3/2024 - at 14:06 - 14:07:39 The two residents in the report can be seen in the classroom in the back corner. Seated in front of the residents is a staff person. Another staff person is seated at the front of the class, facing directly at the two residents. The staff in the front goes to the door to speak with someone. During this time resident [REDACTED] proceeds to reach over to [REDACTED] under his desk. It is unclear what he is reaching for or what he is doing with his hand under the desk. [REDACTED] can be seen looking around the room and then leans his head towards [REDACTED] pelvic region. He does this twice for a brief moment. It is unclear in the video what the purpose of this action is. The incident lasted a total of 1 minute and 39 seconds. The interactions were very brief, approximately 1-2 seconds. After the incident the staff person seated directly in front of the boys can hear them interacting and turned to see what was going on and said [REDACTED] was messing with his pants so the boys were separated. The safety plan enacted for this incident is [REDACTED] has been given a disruption and the facility is trying to find treatment more suited to [REDACTED] needs. It was added [REDACTED] had other difficulties and behaviors unrelated to this incident which were not conducive to the facility. Supervision was increased for [REDACTED] and he was removed from his room and no longer able to sleep with other residents. [REDACTED] sleeps in the hallway or NPR room with doctor's orders until he is discharged from the facility. Re-education and training was conducted for staff concerning classroom supervision and expectations. 4/17/2024 - Licensing Specialist sent findings 521 Inspection report sent to the facility, awaiting signatures.



