Description:

On 04/04/2024 at approximately 1432 hours I, PFC Stuck #325, responded to an Assault call at Perimeter of the Ozarks, located at 2466 S. 48 St. The caller stated she was a nurse at the live in facility for juvenile females. She stated she was attacked by patient and wanted to file a report.

Upon my arrival at Perimeter, I made contact with the caller, who I identified as Sabrina Mclellan (W/F DOB: [REDACTED]). Mclellan stated she was assaulted by a juvenile female, who is in the care of Perimeter, [REDACTED] [REDACTED]). Mclellan stated it was time for a group activity, where all residents were supposed to exit their rooms. [REDACTED] refused to exit her room and they responded to speak with her and attempt to get her to come out. [REDACTED] initially came out, but then ran back into her room and slammed the door. Since staff has key fobs for all the doors, they unlocked the door, but [REDACTED] continued pushing against the door. Other staff arrived and pushed against the door. They spoke with her for a while and eventually went into the room. Mclellan was standing outside the doorway as [REDACTED] was escorted out of the room. As she passed through the threshold of the doorway, she accelerated towards Mclellan, and kicked her in her chest. [REDACTED] then grabbed Mclellan by the hair and pulled her to the ground. [REDACTED] held onto Mclellan's hair with two hands, as other staff intervened and eventually removed her from on top of Mclellan. [REDACTED] was then placed back into her room.

Mclellan stated she this was no the first time [REDACTED] has acted this way towards her or other staff. She stated there have been several instances involving [REDACTED] and she felt it was time to press charges. Mclellan stated she was not injured and there were no marks. I asked her how much it hurt, and if it was still hurting. Mclellan stated it initially hurt, but she has worked as a nurse long enough to know when she was actually injured and when she had not been injured. She did not want to be checked out by medics and did not foresee needing to go to the hospital. Mclellan showed me the video on the security cameras, which confirmed what she had told me about the attack. I asked for the video footage and was told if I wanted it, I would have to subpoena it. My body camera was activated as I watched the footage and may have a good view of the struggle.

Based on the video evidence and Mclellan's testimony, I had charges for Assault 2nd. I called JDC and they

advised they would cite and release [REDACTED] back to the health care staff. JDC provided a court date of 05/01/2024 at 9:00am in Division 3. I provided JDC all the information they needed for [REDACTED] and issued a citation for the charges and their court date. I spoke with Sarah Whorton, the on duty supervisor of the facility, who stated she would be the one to accompany [REDACTED] to court. I provided her with the citation for [REDACTED] and explained the process to her.
