Report Description: Incident Report for client in our PRTF program and resides in Sturgis House Incident Report date/time: 04/08/24 9:40am Location of Incident: Outdoors on the Youth Home Campus Incident Description: Medical Emergency (Trip to ER/Urgent Care), Patient Injury Staff Involved: Barrett Harger, Valerie Alvarez Events Leading: Patient was playing football and when running tripped and fell. On the ground he was grimacing and telling staff that his leg was hurting. He was in a lot of pain and a nurse came to look at him and turned him from being on his stomach to being on his back. After this, the nurses looked at his injury and decided to have him be looked at by an urgent care physician. When the medical staff at the urgent care examined him they told Youth Home staff that he should be taken to the ER due to the severity of his injury. Staff ended up taking him there afterwards. Nursing Assessment date/time: 04/08/24 9:45am: Nursing was called to the field after a client was observed lying on the ground, face down, crying and c/o pain particularly (L) knee. He reportedly was playing football. was assisted in rolling over in order to prevent straining or movement of knee. He c/o severe pain, immobilization of knee, unable to extend, unable to bend, and increased pain upon any palpation. His beanie was pulled over his face as he continued to cry. Increasing amount of bruising and swelling noted, initially beginning at lateral part of knee. Unable to bear weight and c/o feeling of knee buckling and instability. Client was wearing denim jeans, making it difficult to assess above the knee. He c/o increased pain as nurses attempted to roll his jeans up. A cold pack was applied to the affected area. PRN ibuprofen 400mg administered. Client was assisted via (2) team members to a nearby bench ensuring not to bear weight or twist/turn the affected area. MD notified with assessment findings with order to send out for further evaluation. Notes: 1016: Guardian was called and notified of injury and client currently being transported to Urgent care. Guardian expressed understanding. He reported that he plans to attempt to visit next week pending working "some things out on (his) end". 1047: Left guardian a voicemail

explaining to client and team member were now in route to ACH ER following urgent care instructions.  returned from ACH ER at approx. 1445. Dx with contusion of (L) knee.
Xray of knee normal. Care instructions: RICE for 48 hours. Rest, ice, compression, and
elevate. Administer PRN ibuprofen/apap as needed. Follow up if: the pain gets worse, pain
medicine is not helping, or bruised area gets redder, more swollen, or feels hot. Client was
given crutches and placed on activity limit. 1512: Left guardian a voicemail reporting client
returned and instructions above.
Interim Action Narrative: Resident was assessed by the nurse, taken to urgent care, and then to the ER.
