Report Description: [REDACTED] was having an on-campus visit with his mother on 4.13.24. [REDACTED] reported to his mother that staff member [REDACTED] call him a "faggot" and a "nigger". [REDACTED] also stated that he was having an episode of physical aggression and that [REDACTED] physically escorted him away from the situation and brought him to his room. When he arrived to his room, [REDACTED] reported that [REDACTED] "threw him around." The events allegedly happened on 4.12.2024. The mother reported these events to Millcreek staff and informed them that she would discharge [REDACTED] from the facility. She filed a police report with the Fordyce Police Department. Officers arrived on Campus and took statements from both the mother, [REDACTED], and [REDACTED] concerning the allegations. [REDACTED] was discharged from Millcreek. [REDACTED] was placed on administrative leave pending investigation.
