reported that "threw him around." The events allegedly happened on 4.12.2024. The
mother reported these events to Millcreek staff and informed them that she would discharge
from the facility. She filed a police report with the Fordyce Police Department. Officers
arrived on Campus and took statements from both the mother, and concerning the allegations. was discharged from Millcreek. was placed on administrative leave pending investigation.
