On April 22, 2024, at approximately 7:53 P.M., I officer Rice was dispatched to Forrest City Police Department for a walk-in report. Upon arrival I made contact with [REDACTED]

[REDACTED] explained that he was at work breaking up two kids from fighting. [REDACTED] explained how the fight started. [REDACTED] explained that a kid walked in the shower and came back out because he seen a discharge in the shower. [REDACTED] explained that the kid that walked in shower and seen the discharge got into it with another kid because of the discharge.

[REDACTED] explained that after he got the two kids separated, he asked one of the juveniles did he wanted to play spades to calm him down. [REDACTED] explained that [REDACTED] started walking up to him and pushing him. [REDACTED] explained that he wasn't trying to engage with [REDACTED] because he didn't want to lose his job. [REDACTED] explained that he began to back up while [REDACTED] kept walking up to him. [REDACTED] explained that he ended up backing up into a corner and couldn't move anymore, so [REDACTED] began to swing at him. [REDACTED] explained that he began to swing back and hit [REDACTED] a couple times and then stopped and grabbed [REDACTED] so he couldn't swing anymore.

I officer Rice gathered information for the report and notified the Child abuse Hotline because of the statement that [REDACTED] gave about hitting the juvenile.
