Licensing received a provider reported incident on 4/27/2024 for ELS Case #020916

Licensing Specialist Norton visited the facility to review video footage related to the above-referenced ELS case. Video footage was reviewed with Ms. Shannon Rouse, Corporate Compliance Director.

During the video, 8 male residents and 3 staff members are observed in the dayroom of the Boys Unit. Several clients are observed tossing a ball back and forth and another talking to a staff member while sitting at a desk.

Resident is observed walking up to a table and sitting down with two staff members and the older client previously seen talking to staff sits down at the same table. The older client is observed telling staff that the resident is agitating him by humming. The client is informed by the staff sitting at the table that he can move to another area if it is bothering him. Resident continues to hum, and the older male client is observed slapping the resident across the face. A staff member across the room is heard telling the client that he can be charged for slapping the resident and that he could have moved from the table as client continues to argue with staff. The client is observed throwing what appears to be a plastic bucket containing pieces of paper across the room, which hits the wall, making paper fly everywhere. Staff are observed to continue sitting at the table with the resident, while the staff member is heard verbally redirecting the client from her desk. The client is then observed turning his back to everyone in the room while facing the wall, and then placing his forehead against it.

At this point in the video, Ms. Rouse informed licensing that nothing else happens in the video, but that eventually the resident and client were separated without further incident.
