Resident was put in a physical restraint. Additionally, when staff separated [REDACTED] and [REDACTED] [REDACTED] ran over and attacked [REDACTED] repeatedly hitting [REDACTED] in the face, causing a large hematoma above the right eye. When staff intervened, [REDACTED] continued to attack peer and staff; [REDACTED] was also physically restrained. After the incident, [REDACTED] was observed to have swollen knuckles; resident refused ice. [REDACTED] did not have any apparent injuries. [REDACTED] was treated with Tylenol and an icepack and escorted to the ER for evaluation; returned with no further orders or care.

5/22/2024- A visit was conducted to review video footage of the incident. Video timestamp is 5/10/2024 - 13:11 - 13:15 - Residents can be seen entering the classroom and sitting down for lunch. The aggressor [REDACTED] is

seated at the front of the class and facing the victim. The two residents appear to be talking. The teacher hears the residents and tells the tech [REDACTED] who then stands and goes to address the residents. [REDACTED] stands pushes past the tech and attacks the victim [REDACTED]. The second aggressor [REDACTED] seated two rows over stands and begins to walk across the room, the second staff person [REDACTED] sees this and stands to intervene. [REDACTED] gets to [REDACTED] and begins punching her in the face and upper body, the first aggressor is put in a restraint hold and staff try and block [REDACTED]. Other staff enter the room and clear the other residents. One staff blocks the victim with her body as the other staff pull [REDACTED] off. The victim is escorted from the room for a med check while the staff begin to separate and talk with the residents.
