Licensing Specialist Eleanor White reviewed the following incident with Immanuel Morris, Director of Quality and Risk Management which included reviewing 20 minutes camera footage of the hall before and after the incident. Camera footage verified resident [REDACTED] coming on to the hall from the nurse's station kicking and throwing a chair several times. He then started hitting the hall exit doors and a nurse came onto the hall and was talking to him. No sound available on camera footage. 2 additional staff came onto the hall appearing to talk to him and directing the other residents in the hall to their rooms. Footage showed resident grabbing the papers out of alleged staff [REDACTED] hands and ripping it up. Staff [REDACTED] then gets up and resident darts around her grabbing blankets from her chair and runs into his bedroom. Staff [REDACTED] then follows resident into his bedroom with the other 2 staff going into the room directly behind her. Restraint hold was not captured on camera however per agency's documentation during this time a restraint hold was administered. Within the next minute the nurse goes into the room and within the next minute the staff who administered the hold left the room and the hall. The other 2 staff also walking out of the bedroom. Statements from resident, other witness residents, and the nurse's body check report are conflicting. Licensing is not prepared to leave a finding at this time.
