Facility contacted for further detail on horseplaying. of Millcreek stated that after further investigation, it was determined that the clients involved were playing a game call "30's", meaning thirty seconds of play fighting with no punching in the face. Facility policy would not permit staff to allow this type of horseplay. Facility staff stated they do not allow this type of horseplay. A unit wide in-service training was initiated 5/17/24 on staff not permitting horseplay that would endanger the safety and well-being of the clients. Facility visit scheduled for 5/22/24 to interview clients to ascertain if "30's" was permitted by staff. 5/22/24-Facility visited. No citations.
