On May 31, 2024, at approximately 9:53 P.M., I was dispatched to 4253 N. Crossover Rd. for a missing person. Upon my arrival, I made contact with the caller, who stated that [REDACTED] had run away from this location at around 7:30 P.M., but only [REDACTED]. The caller, Nicholas Roper (W/M 09/09/1999), stated he thought staff had called the police earlier when this incident occurred.

Case Supplement:**

On 6-1-2024 I was dispatched to Walmart located at 3919 N Mall Ave in reference to a [REDACTED]. On arrival I made contact with Asset Protection and a white male later identified as [REDACTED]. Jeffrey Pound stated [REDACTED] was caught attempting to leave the store with a skateboard valued at \$29.97 and refused to identify [REDACTED]. The stolen merchandise was recovered. [REDACTED] later identified [REDACTED] to me and advised that [REDACTED] had run away from Piney Ridge (24-37656). I provided Pound with the report number on a contact form and [REDACTED] texted me a copy of the receipt. I later sent him a community request for the video and statement through Axon. I placed [REDACTED] under arrest for shoplifting and began contacting Piney Ridge as well as JDC. [REDACTED] was later released to Piney Ridge and was cited for shoplifting (E0033656). CDC had [REDACTED] removed as missing and canceled the BOLO.
