On June 6, 2024 at approximately 807pm I, Officer L. Dorsey #350, was dispatched to the station in regards to a walk up.

When I arrived on scene I met with Robin Gordon, complainant, who advised me she was bit by [REDACTED], one of her patients. Gordon advised me that [REDACTED] became very aggressive with her and other staff members, she advised me they had to self contain [REDACTED]. When [REDACTED] was self contained Gordon advised me that [REDACTED] began to head butt her and bit her on the forearm. I inspected Gordon's forearm and did not see any bite marks. I advised Gordon I would make a general information report, and I had her to write a statement.
