Report Description: On 5-31-24 at approximately 2000, [REDACTED] and one other resident asked staff for a break from the Crossover unit. Staff took the resident and peers outside of the crossover building for the break. Resident and peers convinced staff to race a third resident, which may have been used as a brief distraction. At that moment [REDACTED] and [REDACTED] ran off the property, the staff immediately redirected the residents to return, which they did not. [REDACTED] was found within 30 minutes by staff with no injuries. Resident will be placed on elopement precautions x24hrs. DON and appropriate parties notified. The Fayetteville Police Department were inadvertently not notified until 2145. [REDACTED] was found at a local Walmart on 6-1-24 and was given a violation of Shoplifting-Theft of Property ? Misdemeanor. He returned to the facility at approximately 1520. Both residents were placed on elopement precautions to be assessed daily, moved back to the main building and will process with therapists. Education was completed with the employee that was attempting to provide a break with the residents outside.

The three staff who inadvertently did not call the police for 1 hour and 30 minutes was [REDACTED] Police were contacted and there was a possible miscommunication of when the police were called. Offsite staff directed onsite staff to contact police at 7:36PM. Program Coordinator requested police documentation. 6/6/2024 - Licensing specialist received proof of retraining for staff in regards to contacting police when there has been an elopement. 6/7/2024 - signed 521 received and uploaded to ELS.

and police contact. Administration Staff instructed on site staff to contact police approximately 36 minutes after the elopement. One resident was found and returned to the facility within 30 minutes. The other resident was still missing. Staff contacted police after searching for the resident for an hour and thirty minutes. Staff were retrained on when to contact police and response after an elopement has taken place.
