Report Description: On 06-2-2024@1630, ([REDACTED]) was outside on the west court, put a poison ivy plant into her mouth, and swallowed it. Staff did try to get the poison ivy away from resident, but it was unsuccessful. It was also reported that resident during the day resident had also place soap and clay in her mouth as well. One of the nurses did give resident a 50mg Benadryl per doctor's order. There was also an X ray ordered for resident's abdomen along with a liquid diet X 48 hours, nothing remarkable was noted on x-ray. Resident did not express that she was in pain or thoughts to kill self and will be place on self-harm precautions X 24 hours. Resident will process with primary therapist.
