On 6/5/2024, at approximately 5:34 PM, I was dispatched to 4253 North Crossover Road (Piney Ridge) for [REDACTED]

On arrival, I located the subject who was last with the [REDACTED], Timothy Sexton W/M 10/26/1980 (PH: 479-684-1998). Timothy stated he was transporting the [REDACTED] from [REDACTED] and had given [REDACTED] permission to throw [REDACTED] trash away in the nearby dumpster. Timothy said the [REDACTED] did not attempt to throw any trash away, but instead ran toward N. Crossover Road and did not stop. Timothy said one of the [REDACTED] was messing with radio controls during the trip and must have snatched his fuel card as it was missing. Timothy stated this all occurred at approximately 5:34 PM that day (6/5/2024).

Case Supplement

On June 5th, 2024 at 10:15 pm, I responded to 578 East Joyce Boulevard for a follow up report. Dispatch advised [REDACTED] were in the drive through of McDonald's and [REDACTED] was not with them.

I arrived and met with [REDACTED] in front of McDonald's and noticed [REDACTED] run across East Joyce Boulevard traveling south.

[REDACTED] stated that [REDACTED] would not stop running because [REDACTED] did not want to go back to Piney Ridge. [REDACTED] stated [REDACTED] were ready to go back to Piney Ridge and I proceeded to search [REDACTED] before helping [REDACTED] get into the rear of my patrol vehicle.

While I was speaking with [REDACTED], an assisting officer was able to locate [REDACTED] south of the call location and convinced [REDACTED] to go back to Piney Ridge.

The [REDACTED] were transported to Piney Ridge without incident where custody of the [REDACTED] was transferred to Piney Ridge staff.
