Events Leading: The client participated during schedule free time on the ball court. Client was playing basketball with his peers and one of his peers from Sturgis attacked him. He was kicked, hit against the fence, punched and hit on his head. Nurse Assessment date/time: 06/10/24 5:35pm: Rec'd pt in patio area in front of basketball court. Pt lead to assessment area of nurses station in admin building w/ QBHP. Pt told to clean up bloody areas. Pt able to understand and follow instruction. Gait steady. Upon assessment, pt is alert and oriented to self/situation. Speech clear. Affect normal. Eyes PERRLA. BP 132/86 HR 100 RR 19 temp 99.2F. Pt has redness to posterior lower neck and superficial abrasion to lower neck that is about 1in in size. No bleeding noted. Redness present behind L ear. Bruising and redness noted to posterior R shoulder/back, redness present on L ear lobe. There is scant bleeding to R ear, there is a superficial abrasion d/t earring scraping ear lobe noted. Area cleaned. There is bruising/redness to L temple above eyebrow. No swelling noted. There are four superficial abrasions to L elbow that have a light amount of blood. Areas cleaned and bandaged placed. Pt has a smaller than dime sized cut to L palm. Scant bleeding noted. Area cleaned and bandaid placed. Pt denies h/a, n/v, light sensitivity, dizziness. Pt denies further s/sx of injury. Talked w/ provider on call. D/t bruising to head/neck, pt taken to urgent care to further r/o concussion. Pt returned, no signs head injury noted on exam per Urgent Care. Pt told to notify nursing of any further complaints. Pt verbalized understanding. No further needs at this time.
