Earlier that day, [REDACTED] was uncooperative and aggressive during a transition back to her unit. Once on unit, she tried to elope off the unit and attacked [REDACTED] punching her with a closed fist in the face, back and chest. [REDACTED] went to the Springdale Police Department and pressed charges. Three officers from the Police Department arrived and issued a warning to [REDACTED] stating they would return if she assaulted staff and peers again. Shortly after they left, [REDACTED] assaulted staff again. Actions Taken: ? Verified Resident is on Assault and Elope Precautions and is Restricted to Unit ?
