[REDACTED] He will be on no sports for 3 days, ice 20-30 min every 2 to 3 hrs as needed and ibuprofen as needed for pain. He was also given Augmentin [REDACTED]. He was not scheduled a follow-up so he will follow-up as needed with our APRN at the facility. [REDACTED] was placed on AP precautions and was placed on reverse 6 foot with staff to help ensure other residents safety.



other residents. The victim can be seen walking in and is approached by the aggressor and punched in the face. Staff immediately separate the residents and the victim was attended by a nurse who walked in behind the residents. The victim was taken to for medical care and was released the same day. The safety plan for the incident was each resident to process with their therapists, separation, and assault precautions. Also the aggressor reassessed every 24 hours.
