Licensing received a provider reported incident on 7/3/2024 for ELS Case #022418.

Program Coordinator reviewed camera footage with Ms. Sherika Williams and Ms. Fatima Stepps. This incident happened in the classroom. Program Coordinator informed that residents were in summer school until 7/10/2024.

Program Coordinator observed residents sitting at desks with staff members scattered throughout the classroom. Including the teacher, ratio was 4:13. The resident and peer were observed sitting side by side in the back of the classroom within arm length distance.

The peer was observed reaching over to where the resident was sitting trying to touch the resident between the shoulder and elbow area. The resident was observed moving over to the other side of his desk while sitting in his chair so that the peer could not touch him. Program Coordinator heard the staff member sitting by the door next to the residents redirecting the peer.

Program Coordinator observed the peer make several attempts to touch the resident between the shoulder and elbow area with the staff member redirecting the peer. Minutes later, resident was observed moving his desk and chair closer to the door out of reach of the peer.

When class was over, Program Coordinator observed two groups leaving the classroom. The resident left in the first group and the resident in the second group. Program Coordinator did not observe the peer touch the resident inappropriately.
