Apparently, [REDACTED] reported that [REDACTED] [REDACTED] gave [REDACTED] his vape to use during the appointment. [REDACTED] [REDACTED] stated that it was [REDACTED] [REDACTED] ". She did speak with [REDACTED] as he was working at the time. After this, PRTC spoke to him and suspended him pending completion of internal investigation.


