Description:

On 7/18/24 a report was received from Arkansas State Police Investigator Christina Duncan in regards to a new report.

The DHS snapshot was reviewed and the following is a summary of the report.

AV is [redacted] (17 yr.); AO is [redacted] (16 yr.). [redacted] and [redacted] are residents at Perimeter Behavioral of the Ozarks and live on the same unit. On 7/17/2024, Youth [redacted] reported to MHT Jenny Areas that another peer [redacted] had kissed her in the dayroom and during hygiene walked into the bathroom that [redacted] was in. [redacted] stated that [redacted] asked [redacted] to "smell her vagina." In a note that [redacted] gave to Lead Kayla Blackburn on 7/17/24 at 1:30 pm, [redacted] states, "When I was in the corner getting my soap and wash towel and a towel and [redacted] kissed me without my permission and then went to the bathroom and [redacted] walked-in on me and made me lick her vagina and then I ran out of the bathroom because I was scared." Residents have been placed on separate units while investigation is ongoing.

After receiving the hotline report on 18 July 2024 I contacted Senior Investigator Chrissy Duncan with the Arkansas State Police Crimes Against Children's Division who is assigned to assist with the case. She said that the females had been separated at the facility and we could interview the victim,

██████████ the next morning.

We arrived at the Perimeter of the Ozarks Facility at about 10:20 A.M. on 19 July 2024. We first met with the Director of Risk Management Charriot R. Sales. She provided us the written "note", a statement, that ██████████ provided to the employee Kayla Blackburn on Wednesday the 17th. She also provided a written statement that ██████████ had written and given to staff concerning the incident.

██████████ written statement briefly describes ██████████ kissing her without permission, and being made to "lick her vagina."

██████████ written statement said ██████████ was in the bathroom and called ██████████ over to see something, and ██████████ pointed at her "coochie" and when ██████████ reacted said "I thought we were together." A second incident happened when ██████████ walked into the hygiene closet to get something and ██████████ came in and asked for a kiss, and ██████████ said no and walked away.

At approx. 10:45 A.M. on 19 July 2024 Chrissy Duncan and myself conducted an interview with ██████████ in a private room. I recorded the audio of the interview.

Chrissy began talking about day to day activities and personal questions with ██████████. At approx. 7:37 in the interview Chrissy asked why she thought we were there to talk to her. ██████████ responded it was about the allegation.

██████████ said it happened Sunday through Monday (July 14-15). ██████████ was playing truth or dare with a group of about 9 girls in the day area, ██████████ was one of them. ██████████ was dared to kiss someone and to lick someone in the private area. When staff went down the hall ██████████ went to the restroom and a girl walked in on her and "made me lick her." ██████████ ran out of the bathroom and asked to talk to Mr. James and Mr. Alex and reported the incident to them and the nurse.

██████████ said it happened between six and seven o'clock on Sunday. ██████████ said she didn't want to participate, but the other girls told her to come over there and sit down. They had been playing the game for almost two hours, but ██████████ played for about 20 minutes. She received only one dare, to kiss ██████████ and to lick ██████████. ██████████ said no, and they "literally forced me to do it."

██████████ was asked to describe how she was forced to do it. ██████████ went into the closet to get her shower things, after she had said no, and ██████████ walked in and grabbed her head and forced ██████████ to kiss her.

█████ specified that by licking it was meant for █████ to lick the vagina, and kissing meant kiss on the mouth.

After █████ kissed her, █████ ran into the first bathroom (301). She was using the bathroom, sitting on the toilet, and █████ walked in and "made me lick her private part." █████ said she had flashbacks to when people had hurt her before like that.

█████ was asked to describe this further. The bathroom has a sink, shower, and toilet, the only door is the door to enter the room. When █████ walked in she leaned █████ head down and told her to lick, and if she didn't she would tell her secrets to everyone. █████ had on a shirt, but she pulled down her pants and underwear. After █████ licked it, she left the bathroom. █████ said stay there, and █████ ran out to tell staff. █████ stayed in the bathroom.

█████ was wearing a shirt, and purple Nike sweats. She was wearing underwear. █████ confirmed she licked █████ on the skin, not over the clothes. █████ was asked to describe it further, █████ said it was nasty and saw black hair.

█████ was asked how long she felt this lasted, she said 20 minutes. █████ was in the bathroom between 1-3 minutes before █████ walked in, and then they were in there together 19-20 minutes. █████ was in there so long because she couldn't get her head free. She said nothing else happened with █████.

█████ said on Monday █████ and another girl woke her up after this was reported. They said "why did you tell, and why are you lying?" █████ got out of bed and tried to charge at them. Staff restrained █████ saying she was the aggressor, but while restrained █████ and █████ through water with ice and a box of crayons at her.

After the physical altercation, █████ was moved to another wing. █████ and █████ still have class together and █████ makes comments to her.

█████ said she and █████ were in a dating relationship together, but broke up after the incident on Sunday occurred.

Upon conclusion of the interview I spoke to Chariot again. She provided a copy of the video from the surveillance cameras. She also said that after speaking to █████ caretaker, she was not allowed to speak to Law Enforcement about this situation.

**Description:**

The surveillance video provided is dated Sunday, 7-14-2024 at 7:06:58 P.M. In the first frame of the video [REDACTED] is the female in the gray T-shirt and dark colored shorts at the far right of the video, she is barefoot. [REDACTED] is standing behind [REDACTED], who is wearing socks, purple pants, a black and orange jersey with the number "13", and glasses. A staff member is in the room with them.

The girls walk down the hallway and the staff member follows. [REDACTED] and [REDACTED] then leave the hallway and go to a closet in the corner of the day room. [REDACTED] runs inside, [REDACTED] stands outside pointing and [REDACTED] walks back out as the staff member returns to the day room with them.

At one minute in the video [REDACTED] and [REDACTED] return to the closet again with another female. The other girl leaves, [REDACTED] walks into the closet, and [REDACTED] stands outside with the door open. While [REDACTED] is inside and obscured from view, [REDACTED] leans forward at the waist with her head inside the room and out of camera view. She is there for a brief moment, and then stands up. [REDACTED] then walks into the room with [REDACTED] as several girls watch them. [REDACTED] and [REDACTED] walk back into the room together, [REDACTED] is smiling as she rejoins the circle of girls. [REDACTED] paces the floor as the other girls go back and forth from the closet.

At 11:53 on the video (7:18:52 PM) the staff member gets up to leave. As he walks down the hallway the girls are still in a circle together in the day room. After he gets up, a female sitting in a chair excitedly points toward where the staff member was sitting. [REDACTED] gets up quickly and runs to a room next to where he was seated [REDACTED] gets up with her and walks behind. Several of the other girls in the circle get up excitedly, laughing, talking, and looking around. They are looking into the room that [REDACTED] and [REDACTED] walked into, both out of view.

The other girls are giving hand signals and saying something to [REDACTED] and [REDACTED]. As [REDACTED] walks out the female that first pointed toward the staff member leaving runs excitedly back to her seat. [REDACTED] walks out first, [REDACTED] walks out second. When [REDACTED] walks out, her hand is in her shirt possibly adjusting her clothing or wiping her hands. Both girls rejoin the circle as another staff member enters the room. The video ends there.

[REDACTED] and [REDACTED] enter the room together at 12:03 on the video (7:19:02 PM), they exit the room at 12:23 (7:19:21 PM), a total of 19-20 seconds.

After reviewing the video, I contacted Charriot Sales to see if there were any further incidents that would have occurred after the video ends. Here is her reply:

Hello,

After the incident, you can see [REDACTED] and [REDACTED] briefly talk, and [REDACTED] processing with staff. [REDACTED] did tell staff that [REDACTED] was going to make sexual allegations against her, but [REDACTED] didn't make any. Between the two, there was no further questionable behavior.

**Description:**

In the video [REDACTED] appears to be an excited participant in the activities the girls are involved in, and is the first to get up and run toward the room that [REDACTED] followed her into. The video cannot see what [REDACTED] and [REDACTED] do together in the room, but there are multiple girls (residents) who are watching them. Both times they were out of camera were moments that they were also out of view of staff. [REDACTED] appears to have been leading [REDACTED] each time they enter a room out of view of staff. They are only out of view together about 20 seconds.

[REDACTED] described being in the bathroom 20 minutes with [REDACTED] and said that she did not consent to the kissing or sexual contact. [REDACTED] said that she was cornered in the bathroom and physically forced to kiss [REDACTED] and to lick her vagina.

The video evidence does not support the sequence of events as described by [REDACTED], I do not find sufficient probable cause to charge [REDACTED] with Sexual Assault.
