Report Description: on 7/29/2024 in the afternoon - PRTC received this email from [REDACTED]  
[REDACTED]  
[REDACTED] that involves a former resident of Piney Ridge. [REDACTED] name is [REDACTED]. [REDACTED] is alleging that staff would give vapes, dab pens with cannabis in it, cigarettes, lighters, and cell phones to the residents. It appears that this might have happened at the group home. [REDACTED] said that the contraband was hidden along the fence line. [REDACTED] is also alleging that staff would allow the residents to fight and work it out. [REDACTED] said that this would happen where there are no cameras. [REDACTED] is alleging that a staff member and resident went to the same area and fought. [REDACTED] is also alleging that staff would show inappropriate videos to the residents. Videos of girls nearly nude, in very little clothing dancing. [REDACTED] stated that it was close to pornography but wasn't." [REDACTED] didn't provide any staff names or residents names. [REDACTED] says that staff threaten to write residents up, falsify restraint papers, to try and get the kids in trouble. [REDACTED] was admitted on [REDACTED] and [REDACTED] at maximum gains and ended up in [REDACTED] for charges. Unknown what [REDACTED] is referring to, contraband with residents can be an issue, a staff member could have dropped a vape - policy put in place that vapes and all tobacco products are not allowed in the building.

During the walkthrough none of the items reported in the complaint were found in outdoor recreation areas nor any items which pose risk or harm to residents. Outside the fence row areas were inspected during the walkthrough. Items mentioned in the report were not found in these areas. The facility property borders an apartment community and trash and other items were noted during the walkthrough on the outside of the fence row not accessible to residents outside. The facility maintains this area periodically for items that may end up on the facility grounds from the neighboring properties.
