****Sex Offense reported Hotline****

On 07/17/24 a Child Abuse report was received from Arkansas State Police Investigator, [REDACTED], in regards to a new report. [REDACTED].

The following is a summary of the DHS Snapshot report:

The Alleged Victim is [REDACTED], the Alleged Offender is [REDACTED]. [REDACTED] and [REDACTED] are residents at Perimeter Behavioral of the Ozarks and live on the same unit. PRFC's are [REDACTED] and [REDACTED]. On the evening of 07/16/24, Residents [REDACTED], [REDACTED] and [REDACTED] submitted statements to the Director of Risk (DOR) regarding the alleged sexual misconduct of peer [REDACTED] in which [REDACTED] reports, "they would bend me over and touch my boobs and butt and flash me and try to see me change like holding my bathroom door open and looking." The DOR verified [REDACTED] was assigned her own room and staff was in ratio. On the morning of 07/17/24, the DOR interviewed the youth. During [REDACTED] interview, she claimed that on multiple occasions over the last few weeks [REDACTED] touched her breast and butt and laughs off her attempts to say no. She also reported [REDACTED] has flashed her breast at [REDACTED] a couple of times and has tried to hold her bathroom door open while she is changing. Both [REDACTED] and [REDACTED] stated they witnessed this behavior. A peer restriction is in place while this is an ongoing investigation.

During the interview [REDACTED] stated that she was talking to another patient when a staff member overheard [REDACTED] and told her that she needed to write a statement as to what she had been talking about.

[REDACTED] denied any type of unwanted sexual contact or battery and described most of the activity as playful conduct that most of the girls in the behavioral unit do.

I have attempted to contact [REDACTED] attorney ad li dem to see if they would allow me to interview [REDACTED]. As of 09-30-24 I have not head back from them. [REDACTED] told me that State Police was closing this case unfounded.
