The resident reports no other staff or residents have ever witnessed this because it happens when they are alone. Licensing program manager visited the facility in response to case 022967. Licensing spoke with facility staff Tiffany Harris and therapist Zachary Hale regarding the provider reported incident. The facility reports that the staff named in the case is currently on leave pending the internal investigation.

Licensing interviewed three residents at the facility including the child named on this incident report.

Resident 1: Reported that one staff (listed on this report) has been rude and disrespectful to him on several occasions. Reported that the named staff has threatened to punch him in the face after the resident bumped into his chair. The resident reports that no other staff or residents heard these exchanges as they were always alone when it occurred. The resident reports no other issues with any staff, reports that he really likes his therapist, his room is nice, and he feels that he is making a lot of improvement at the facility.

Resident 2: Reported that he has no concerns with any staff at the facility and has not witnessed any staff being physically or verbally aggressive with any residents. Reports that he enjoys the facility because they go on outings, have good food, and they can play basketball. Resident named two staff specifically that he really appreciates for being so kind.

Resident 3: Reportedhe has no concerns with any staff at the facility and has not witnessed any staff being physically or verbally aggressive with any residents. Does report concerns about his discharge plans and if he can get a set date to discharge on because his family is trying to move out of state.

Licensing spoke to CEO Waynette Banks and reviewed the information gathered today. Licensing informed Waynette that licensing is not requiring the staff to be on suspension, and he can return to work once he has been retrained on topics related to appropriate communication and behavior management with the residents. The facility will provide a copy of the retraining prior to the staff returned to work.
