Narrative:
Facility visited in response to complaint that staff grabbed client out of his chair after kicked him. Video reviewed shows just that. Two staff appear to be counseling client while he was sitting in a chair visibly upset. Staff walks toward at which time kicks staff Staff then aggressively grabs client leg and pulls him out of his chair, hitting the floor. Facility cited 109.1g and 905.4g. Staff immediately walked out of facility after this incident and has since been terminated. This incident occurred 8/3/24 around 6PM and was not until 8/4/24 around 8:30PM. Facility cited 110.9. Unit wide training will be held on mandated reporting. Training sign-in sheet will be provided to licensing.

Provider Comments:

This incident does not reflect the standard practices or the de-escalation techniques that our facility rigorously implements to train staff in the interaction and management of residents in our care. The actions mentioned in this citation were conducted by an individual staff member who strayed from the extensive training and protocols our facility has established. We take incidents of this nature and patient safety with utmost seriousness. The actions taken by this employee were outside of their assigned responsibilities. Our facility made the decision to terminate the employee due to their actions deviating from our company policies. He chose to resign effective immediately. His resignation was accepted and he will not be eligible for rehire at any time. Furthermore, our staff are trained in timely mandated reporting. We will be conducting another training about mandated reporters and timelines.
