Maltreatment Narrative: AV is approximately 13yo [REDACTED]. AO is age unknown [REDACTED]. AV is currently at Perimeter Behavioral Health in Forrest City, Arkansas. AO is an employee at the facility. AV reported that he and AO were in a heated argument and AO choked him in his room at 2230 on 08AUG2024. AV stated he could breathe with no problem.

Licensing Narrative: 8/13/2024, Program Coordinator was informed via telephone by CEO. 8/14/2024, Licensing looked in [REDACTED] for assigned [REDACTED] and requested permission to contact the facility. 8/16/2024, Licensing followed up with [REDACTED] for permission to contact the facility. Permission granted. Program Manager visited the facility and reviewed camera footage. 8/20/2024, facility provided documentation from the [REDACTED]. Staff member will be retrained on de-escalation techniques. Program Coordinator request4ed documentation of training once completed. 8/22/2024, facility provided documentation. Case completed.

Licensing visited the facility to discuss complaint case 023232.

Licensing reviewed camera footage dated for 8/11/2024 starting at 21:26. There are three staff on the unit and residents can be seen standing in their doorways. At 21:28 the A/O can be seen entering the bedroom of resident [REDACTED], and the A/V. The staff exits shortly and returns back into the room at 21:29. The facility reports that the staff had entered the room because the A/V was starting to become upset with his roommate and the A/O entered to keep distance between the two residents. The A/O can then be seen calmly exiting the room at 21:30 along with the A/V as they appear to be calmly talking with one another. One staff, [REDACTED] had a clear view of the bedroom as she was sitting in a chair outside the room and witnessed the A/V and A/O's interactions. The video recording ends at 21:32.

Licensing obtained witness statements from the two roommates present in the room during the incident, the A/O and staff [REDACTED] on the unit.

The A/O began work at the facility on 6/10/24 and has had no other complaints made against him. The A/O was trained in Handle with Care on 6/12/24.

The staff is currently placed on suspension pending the results of the investigation. Licensing is not prepared to leave a finding at this time.
