Report Description: On 08/14/2024, [REDACTED] reported to a staff member that [REDACTED] had let her, and peer [REDACTED] use her nicotine vape on more than one occasion. [REDACTED] was suspended pending internal investigation, and a [REDACTED] call was placed and accepted [REDACTED] spoke to the two residents on 8/16/24.

Interim Action Narrative: Staff placed on leave pending investigation.

[REDACTED] and another Piney Ridge patient [REDACTED] said they went with [REDACTED] to an area of the facility that does not have cameras so they could use her nicotine vape. She let them use her nicotine vape. Then they went to another area in the facility with no cameras. They vaped there again, and they vaped in one of the girls' bedrooms. [REDACTED] will likely be in Piney Ridge for another six months, probably.

Licensing Narrative: 8/19/2024 - The provider reported incident was reviewed by the Licensing Specialist. Licensing specialist spoke with the facility concerning the residents having access to employee's personal belongings. The facility has implemented new

policies concerning the personal belongings and cell phones being placed in a secure location while on the floor. 9/11/2024 - [REDACTED] finding requested from supervisor. 9/16/2024, facility inquired if ICA could be lifted due to unsubstituted finding per documentation from [REDACTED] 9/17/2024, Program Coordinator inquired if staff member would receive training. Facility reported staff member would receive additional training of boundaries and zero tolerance of any type of abuse. Program Coordinator requested documentation once training is completed. 10/9/2024 - Licensing specialist followed up with the facility for confirmation of retraining dates and documentation. Facility response was that the employee was not retrained as they are no longer working at the facility.
