On 08/19/2024 I was dispatched to 211 Church Street to the Dacus facility for an assault that had just occurred. I arrive at the address and make contact with a male employee who stated that one of the male juvenile's in the facility had assaulted another staff member [REDACTED]. The statement was filled out by the employee with his name and information on it but it was left at the facility on accident and will be retrieved on 08/20/2024 and attached to the report.

The employee I made contact with directed me to where [REDACTED] was at. On the way there, the employee stated that [REDACTED] was still laying in the floor due to having rib pain as well as back and hip pain and couldn't get up. I spoke with [REDACTED] as he laid in the floor while EMS was en route to the location. [REDACTED] stated that the juvenile came at him full force from one side of the room and extended out his elbow into [REDACTED] left side area. [REDACTED] stated that he never seen the juvenile coming at him until he was hit by the juvenile's elbow. [REDACTED] stated when the juvenile made contact with his left side, it caused him to be knocked into the wall and then from the wall, into the floor which is when he hit his hip and back on the floor. [REDACTED] complained of side pain as well as hip and back pain to me.

EMS arrived on scene and tended to [REDACTED]. [REDACTED] was transported to NEA Hospital to be checked out due to his injuries. Trauma Band Number for [REDACTED] is C209252.

I contacted the on call juvenile officer, Amy Powell, and advised her of the situation and she stated to transport the juvenile to the juvenile detention center. All of the juvenile's information that was needed was given to Officer Powell.

Due to staff advising me that the juvenile had made comments of not going easy, I asked dispatch to send me another unit just in case the juvenile decided to try and fight. CR12 and CR42 arrived at the address to assist me. I then placed the juvenile into handcuffs, checked for fit, and double locked them, without incident. The juvenile was placed into the back seat of my patrol car and transported to Craighead County Juvenile Detention Center on the charge of Assault 3rd and released to jail staff.

A copy of the report was emailed to Juvenile Officer Powell. Nothing further at this time
