On 08/22/2024 at approximately 6:39 p.m., I, Officer I, Gardner #263, was dispatched to 600 North 7th Street (Perimeter Behavioral Health) in reference to a runaway juvenile complainant.

Once on scene, I made contact with staff member Felicia Pini. Felicia stated the runaway juvenile, [REDACTED], had been asking to go back to the courtyard since 3:00 p.m. Felicia stated when it was about time to go inside [REDACTED] decide to take the chance and climb the fence while the staff was dealing with a situation with another resident. Staff members tried to stop [REDACTED] from going over the fence. When [REDACTED] went over the fence [REDACTED] ripped the white shirt [REDACTED] had on. [REDACTED] ran towards the back of the building in the woods.

Officer G. Bowman deployed his K9 for a track. He lost the track at a tree line to the west of the facility.

[REDACTED] was last seen wearing a white shirt, pink pants and socks. I obtained a photograph of [REDACTED]. I obtained a written statement from Pini. I completed A Child Is Missing questionnaire.

[REDACTED] was transported back to 600 North 7th Street. [REDACTED] was checked out by EMS due to banging [REDACTED] head on the patrol unit #2176. The Crittenden County Dispatch cleared the NCIC.
