He validated his phone number and gave me the phone number for the charge nurse in case we needed to contact the facility after his shift was over at 0700 the next day. I then put the two juvenile's information into a report and notified dispatch to mark them as missing persons and to put a BOLO out for them.

On August 22, 2024 at approximately 2120 hours, I was dispatched to Piney Ridge for a recovery report. Upon arrival I made contact with Mr. Roper who stated that the juveniles had returned just prior to him calling 911 for a new report. He told me that the juveniles had just walked up and down the road before coming back. I put eyes on the but was in the shower. Both juveniles were safe and in custody of the facility.


