On Friday, August 23rd, 2024, I, Officer Neil Brasse was dispatched to Mill Creek to assist with the locating of a missing juvenile. The juvenile was

described as white female, [REDACTED], [REDACTED] brown hair, wearing a dark blue hoodie and black leggings. Staff at Mill Creek stated that she escaped from the facility while attending the on-site school. Staff followed her from the school to HWY 79, where they lost track of her. Upon my arrival I began searching the immediate area North and East of the facility. During which time, Dallas County Sheriffs Deputies deployed an arial drone. During a search through the woods east of the facility, one of the staff located her and she attempted to flee. Using my vehicle, I drove ahead to cut her off. At this point I found her standing behind a large tree at 2321 US-79. I notified staff and deputies where she was and she was taken into custody. At this point she was safely returned to Mill Creek with no obvious or apparent injury.
