Report Description: Incident Report for client in our PRTF program and resides in Sturgis House Incident report date/time: 09/09/24 8:35am Location of Incident: Sturgis House Incident Description: Aggressive to Adults, Threat to Safety, Property Destruction Staff Involved: Jonathan Pulliam, Barrett Harger, Marilyn Howell Events Leading: UM received a text from staff saying that they may have to do an all call due to behavior. I replied that I was on my way. Once was observed "bowing up" on staff threatening to punch them. entering Sturgis, was asked what was going on and replied that "this place is just like all the others". began walking around the milieu throwing things off staff's desk and flipping over then walked towards the front door and with one kick, kicked it open and want outside. 8:35am-Personal Restraint: was placed in a personal restraint after kicking the front door open and going outside. Pt was escorted back into the house. is cursing and yelling at staff as staff try talking with him. 8:36am-Personal Restraint End: is released in the comfort room. is seen is continuing to yell and threaten staff. punches the window to the comfort room. Staff are able to continue talking with him and he is able to calm and be assessed by the Nurse and return to his area. Patient Debriefing date/time: 09/09/24 9:00am: talked with his therapist about his behaviors. was able to return to his area with no further issues thus far. Injuries to staff or client: PT's right pinky knuckle swollen Follow-up to the injury: Ice pack given. Pt will be going to Urgent Care or ER when deemed safe to do so Note: This UM initiated the personal restraint. Pt left at 1730 for Ortho Urgent Care. Pt returned at 1950 results of the visit are as follows Recommendations are use ulnar gutter brace, elevate right hand at rest, take nsaids or tylenol prn for pain. Wear brace until symptoms improve. Nursing Assessment date/time: 09/09/24 8:50am: Pt. seen after being placed in a physical restraint from 0835 - 0836. Pt was informed that he could not attend school today and became very upset; he was aggressive with staff, destroyed property, and

became a threat to safety. When I arrived, pt. was in the comfort room looking out window with therapist speaking with him. Pt. agreed to let me to a physical assessment on him. Pt. calm currently, able to come out of the comfort room and walk to the milieu. No abnormal gait noted, pt stated that he is having pain in his right hand. Redness noted to knuckles, capillary refill<3secs, has limited ROM, pain verbalized when attempting to close hand, tenderness noted to right pinky when palpated. Pt. has possible injury to right pinky as it does not align with other fingers when pt. extends finger. Pt. has small wound noted to right index finger; area cleaned, triple antibiotic ointment & Band-Aid applied. Pt. denies any other injury. VSS: 96% on RA, 147/94. 89, 18, 10/10. The provider present during assessment wants to send pt. to urgent care to have hand x-rayed for injury & treatment. Guardian was notified on 09/09/24 at 9:03am and 9:35am. Urgent Care paperwork will be emailed to Kendra Slade on 09/09/24

Interim Action Narrative: Resident placed in a restraint for safety, assessed by the nurse, and evaluated at urgent care.
